The President, after verifying that the legal number of attendees has been reached as stated by the By Laws and therefore confirming the validity of the present meeting, brings to the attention of the BoD for discussion the following agenda:

1. BoD Titles 2017: New Treasurer

The President asks who among the attendees is interested in the vacant position of Treasurer. Jean Pierre Biard and Marco Staccioli submit their candidacy. The President calls the BoD to vote upon the two candidates. The result of the elction is 4 to 2 in favour of Jean Pierre Biard.

2. BoD Meetings – yearly calendar

4. Kansai activities

Flavio Gori proposes to the BoD an implementation of the presence of ICCJ in Kansai with a possible affiliation with an institution in Osaka. The Vice President proposes to discuss in further details the collaboration based on a business plan. The BoD agrees to postpone the discussion on a detailed proposal.

5. Calendar of events 2017

The SG gives a quick overview on the events and activities planned for 2017. For the events: 12 seminars, 5 business Italian courses, 1 yoga class, 12 Aperitivo, 5 Chambering in collaboration with foreign Chambers in Japan –the first one being planned with the American Chamber- 2 Gala Dinners and all the annual brand events for the promotion of Made in Italy: JOOP, Gran Concorso di Cucina, Biritalia, Italia, amore mio! with a potential new edition in a different prefecture. For the assistance to PMI: 8 Trade Shows, market researches and consulting (forecasted in approximately 60 services), missions, delegations amd BtoB meetings (approximately 20 companies), new custom-made services for Members and companies in Japan (luncheon and receptions upon request aimed at selceted target).
